



1. GE Recommendations for GEAR Approval Process

Meeting Notes:

Review the courses for approval at next meeting February 21, 2023. Need to reach out to CDC about the ES 309 proposal and policies.

ICC meeting: time for discussion a bit late. Conversation has been happening. Could be further along. Process - GEAR being charged with program review.

Pushback faculty about GEAR last freeze. Last GEAR program (setting of PLOs). Wonder when freeze happens to be open about where door is open and when it is open. Review and process for (1 year probationary something). What that would entail. Rules around the freeze. What's on the docket. If it requires no review. Limited review.

A1- departing long term practice.

What happens with the freeze? Who can get through? How to be clear with people. Not giving "stated option for urgency" from equality standpoint it's equal. Everybody is on this. No question. Exigent matters that are beyond GEAR. as ar as GERS goes we are on a hiatus.

Workload issue. Full time job

If GE is coming as part of new program or program innovation maybe we can consider. Lots of GEs are coming in isolation (Freeze)

Assessment part - have not addressed yet. When we review GE different areas, assessments should be an integral part. How assessing. Assessing area specific learning outcomes. Built into courses through canvas. Discussion with CTL - built into system. Not being able to use it (assessmnet with the Canvas)

One person proposes course - one set of assignments and course is assigned to someone else redesign GEAR syllabus. Whether course meets learning outcome of specific area or not nobody knows. One person writes proposal and looks at learning outcomes and another teaches course they might not look at the learning outcomes.

Canvas assessment - would that work across the board for GEAR review?

Going to department, areas fall under. Commitments. If you were going ot set humbolt specific guidelines.

Transparency - go to programs and being clear on the website - agendas from the meetings. Minutes from the meetings. Mystery of send a course to GEAR and we don't know what happens there. Sanitized version of the notes form the shepherding process. Where GEAR fits in the campus culture with regard to what students think it is. Students "get a GE out of the way" opportunity to be multidimensional. GE enriches life. How GEAR is advised about. DARS degree planner. Want to only advise about Major classes. (Pick a GE class). Outline in head GEAR has a place in the planning (not just a throw away thing). Having some aspect - some incorporate a lot of double counts (get major course as GE course). Some really don't. Refer to Environmental Studies (very few intro in major that are GE). can't take exploratory in ENST and have it also count in GE area. Taken elective units etc. why do some do it and why not?
