  - 1. would like to move forward with the work but not in this specific space as bookstore is not a desirable venue
  - 2. applicant requested funding and equipment for the installation
    - a. \$40k, plus \$10k
  - 3. James Woglom asked if the clause in mural guidelines would be valid to relay back to the applicant
    - a. (2b) to identify and designate reasonable locations for the installation of public artworks. Alternate locations for the installation of new public artworks can be considered as they arise, but would be subject to review and approval by the USFAC. Timelines detailing the date of the installation of campus artworks, including the agreed upon review period and terms of the installation, should be reviewed annually in order to assure adherence to these agreements.
  - 4. The group discussed determining other locations on campus as possibilities.
  - 5. Roohparvar expressed concerns that the proposed location would be subject to vandalism.
  - 6. James Woglom stated that the artist and art gallast be involved in the future discussions.
