#### 6. Other Items

- a. <u>Capital/Infrastructure Projects Update/Team Domino</u>
  - i. The committee reviewed the new projects described in the link above, including renderings for Engineering & Tech building and Energy Research and Sustainability Center building. Also discussed the status of the Student Housing project in construction on St. Louis Rd (Craftsman), as well as the design status of the Housing, Dining and Health project centrally located on campus. Science Complex has funding for renovation across A, B, C, and Alister McCrone Hall and Facilities Management is assessing the feasibility and priorities for renovations.
- b. Campus Physical Plan Update
  - i. Assessment is underway to meet our goal to serve 12,000 full time equivalent students and about 700,000 assignable square footage (about 1 million square feet total).
  - ii. Most of this would likely be infill in the areas on campus currently underdeveloped (upper playing field), or developed with parking lots, and could include moving athletic programs offsite (Foster Avenue property).
  - iii. By summer 2024, the plan should be closer to completion, and will be under CEQA review.
  - iv. SmithGroup and Facilities will be preparing a presentation 'roadshow' in the future
- c. **Bylaws** Update
  - i. Co-Chairs to assess next steps, then request committee members to review as a subcommittee.
