Resolution on the Recommendations Being Made to the University Resource Planning and Budget Committee on the Humboldt State University 1991/92 Budget Cuts (#29-90/91-EX)

- WHEREAS, The President's Office, Academic Affairs, Administrative Affairs, Student Affairs, and University Relations have made recommendations to the University Resource Planning and Budget Committee (URPBC) on cutting selected functions in each area to meet the Humboldt State University expected 1991/92 budget; and
- WHEREAS, The faculty representatives to the URPBC seek advice from the Humboldt State University Academic Senate on the recommendations that have been made to the URPBC on cuts to meet the Humboldt State University expected 1991/92 budget cuts; and
- WHEREAS, The recommendations made to the URPBC include catastrophic reduction of the Academic Information Referral (AIR) Center, elimination of the Testing Center, catastrophic reduction of support for Academic Computing, and reduction of course offerings to the extent that Humboldt State University will only be able to support approximately 6100 to 6400 FTES (400 fewer than the budget level); and
- WHEREAS, The recommended reduction of the AIR Center, elimination of the Testing Center, reduction of support for Academic Computing, and reduction of course offerings to the support level for approximately 6100 to 6400 FTES is not in accord with the Humboldt State University Mission Statement which holds that ". . .instruction is central to the mission of Humboldt State University. . . ."; and
- WHEREAS, The catastrophic 1991/92 budget cuts being required at Humboldt State University require imaginative approaches to supporting instruction including approaches that reduce services that least affect the academic program; therefore, be it
- RESOLVED: That the Academic Senate of Humboldt State University recommends that the URPBC recommend and the President implement actions in cutting the budget for 1991/92 that maintains the services of the AIR Center at its current level; and be it further

RESOLVED: That the Academic Senate of Humboldt State University recommends that the URPBC recommend and the President implement actions in cutting the budget for 1991/92 that maintains the Testing Center in its current form; and be it further

RESOLVED: That the Academic Senate of Humboldt State University recommends that the URPBC recommend and the President implement actions in cutting the budget for 1991/92 that reduces Academic Computing no more than Administrative Computing; and be it further

RESOLVED: That the Academic Senate of Humboldt State University recommends that the URPBC recommend and the President implement actions in cutting the budget for 1991/91 that maintains a level of class offerings that supports a FTES level of approximately 6800; and be it further

RESOLVED: That the Academic Senate of Humboldt State University recommends that the URPBC and the President review the attached list of ideas for possible fund sources for application at Humboldt State University in accommodating the expected budget cuts for 1991/92.
