Currently, UPD stores bulky evidence and found property in the greenhouse basement. The allocated space is approximately 11' x 20', and is comprised of a plywood and chain-link cage. This space is not in compliance with police and property storage best practices. In addition to the fact that the space is accessible to others, the rodent and mold issues exacerbate the challenges.

## Proposed Use, Square Footage, & Capacity

Because of the mold and environmental conditions in the current space, we are not seeking change to the existing space. Rather, we are seeking different space altogether. Property in UPD care/control is our responsibility, as is damage caused by storage conditions. The present conditions in the existing space are not conducive to the safe storage of property in our care/custody.

## Request Importance - Needs Analysis:

Inadequate security, mold, and evidence of rodents makes this space less than ideal, and out of compliance with police evidence security and storage best practices. While the need is immediate, it is not necessarily urgent. That said, liability is present if current conditions are not addressed.
