The Office of Student Life [OSL] primary offices, storage rooms and meeting spaces are currently spread between 2 buildings (University Center and NHE 115). They have a student organization storage space in NHE 115, additional office storage in UC 122 (1st floor in dining space), and then our office is located throughout the 2nd floor of the UC (240, 240A, 240B, 250C, and 250A).

Proposed Use, Square Footage, & Capacity

Here is the proposal in a snapshot:

Shift the Office of Student Life from NHE 115, UC 122, and the UC 240 rooms to the old AS office space (Rooms UC 242, 246F, 246E, 246D, 246C, 246B, 246, 246A, 244, 242A)

Student organization storage from NHE 115 to UC 246 E & D to open up additional space for the Associated Students

This will provide space for student staffing for campus programs to hold office hours in UC 246F instead of the UC Lounge UC 250

UC Lounge 250 could then become a "student hub" being worked on with the student task force

UC 244 would be the Student Life Coordinator Office

UC 246A would be the Student Life ASC Office

UC 246B would the Social Justice Center Coordinator Remote office

UC 242 would be the Front Desk Staff for Student Organizations

UC Lounge 250 and UC 240 space can then be transformed to a student center hub that is currently being worked on by the task force.

The NHE first floor and old bookstore location on the UC upper level would then

be able to be mapped out as part of the student center plan in a cohesive manner. Exact locations of what would be where is not yet determined, but this is TBD is allocated.

Request Importance - Needs Analysis:

In 2020 President Jackson charged Vice President Meriwether and Dean Turnbow to re-imagine ways to create a more student centered University Center and/or NHE. This request is a big picture overview of what this looks like across numerous areas within the division. This is a combination of movements for additional or alternate square footage without a specific room/space/location already identified.

The Associated Students currently as they are house do not have enough space for their operations with the staffing they have. Their core programs are spread across campus, making it difficult for them to manage and support students. If they moved to NHE, it would allow for them to be in one location with their sponsored groups, as well as frees up the opportunity for the Office of Student Life to move to this larger space to better support student organizations.

The OSL does not have the ability to ensure the security of Student Organization supplies because there is no staff stationed in NHE 115, as well as the staff members do not have access to the storage space in UC 122 when the dining area is closed. This impacts campus programming greatly when sound equipment for late night events are needed with no way of accessing it.

University Center 250, the remaining areas of NHE, and the old bookstore location on the upper level are connected to transforming the space to be more student centered. Currently, our students use our library as the "hang out" space because there is no designated space on our campus for student engagement in this capacity. We are proposing using UC 250, NHE and the bookstore location to establish a true HSU student center experience. Currently, a taskforce of 8 students (AS, RHA, Y.E.S., Fraternity & Sorority, Athletics, Club sports, El Centro, ERC and OSL) is being Co-Chaired by the Dean of Students and UC Director to establish what these spaces shall become. A survey is in progress and should disseminate next month for more student input and votes. Thus far, discussions from students have been but not limited to: a student commuter lounge, gaming space, unique style programming space, student club meeting spaces, hangout music hub.




