The University Executive Committee meeting included:

- A presentation by the local community development agency.
- An update from advancement on fundraising initiatives and progress. HSU continues to lead the CSU in terms of percent of alumni giving, our average alumni gift size has declined in the past year. Advancement is also developing broader strategies for engaging with alumni beyond fundraising.

University Resources and Planning Committee (Eschker):

The URPC met on Friday October 25 and covered the following:

- 1. Review fall enrollment census data and the impact to revenue in 2013-14.
- 2. Review student enrollment metrics for multi-year trending and planning.
- 3. Discuss enrollment funding options and the marginal cost allocation model.
- 4. Discuss the 2014-15 resource request process using PREP Planning.

The committee discussed the projections for replacing the WUE students, and this year's decline in International/Out of State students. The committee was generally behind the idea allocating future enrollment growth money by "smoothing" funding to the divisions using three year averaging, with funding based on marginal cost estimates from the Chancellors Office. A portion of enrollment growth money would be held as "discretionary" funds that would be allocated as "one-time" with recommendations by the URPC. The PREP Planning model for budget augments is still being formed.
